1. RFP should be responded to and quotes provided by Friday, May 12<sup>th</sup>. Purchase Order and monies must be encumbered by June 30<sup>th</sup>, 2017.

2. Proposals must be submitted based on equipment delivered and assembled inside the cafeteria. Vendor is responsible for the removal from the location any and all packing and shipping materials or other debris from the delivery and assembly of items received.

3. Vendor must meet trucks to receive and assemble shipment.

4. Proposals submitted must include any and all freight and handling cost. The Dalton Public School's School Nutrition Department will pay no additional charges

5. The bidder's and manufacturer's representative's responsibilities to the Dalton Public School include, but are not limited to, handling any problems with products supplied and any necessary instruction on use and upkeep.

6. When an article of particular make or trade name is specified, it is meant to establish a quality standard and is not intended to eliminate competing articles of equal quality. Bidders are at liberty to quote on substitutions provided complete specifications are included with the bid. Vendor is also required to describe all exceptions to our specifications and include a color photo. We need the URL for the manufacturer website for the product listed. If no substitutions are indicated, it will be assumed the quotations are based on our specifications.

7. Time of delivery is a part of this consideration and must be stated in definite terms and must be adhered to completely. Delivery must be complete on or before the specified date. Items will not need to be received on site before Wednesday, July 21, 2017. All items must be installed by Friday, July 23, 2017.

8. No partial payment will be made. The total amount of each purchase order must be encumbered by June 30, 2017 per Georgia Department of Education Equipment Grant requirements.

9. The bidder, by submitting their proposals, certifies that to the best of their knowledge, neither they nor any of their suppliers discriminate against any employee or applicant for employment because of race, religion, color, sex or national origin.

### MOBILE TRAY AND SILVER STAND

### ONE (1) EACH

- A. Furnish one (1) each mobile tray and silver stand model SCTS-36 as specified as manufactured by Delfield. Unit to be 36" wide x 30" long x 30" high.
- B. Exterior body shall be constructed of 18-gauge stainless steel side panels and 14-gauge galvanized bottom. Provide laminate exterior panels in lieu of stainless steel exterior panels.
- C. Exterior top shall be constructed of 14 gauge, type 304 stainless steel with a No. 3 finish, welded, ground and polished into one integral unit. Top shall be fabricated with square exterior corners. Top shall have area for silverware with stepdown for trays.
- D. Unit shall be mounted on 6" high swivel casters with non-marking polyolefin tires and plate brakes.
- E. Unit to be provided with the following accessories:
  - 1. Line-Up Interlock Device.
  - 2. Laminate Panels.
  - 3. Custom Graphic Wrap for Submarine Design- Wilson Art Ocean D502-60 Matte Finish on the Base.

**HOT FOOD COUNTER**  
**ONE (1) EACH**

- A. Furnish one (1) each mobile hot food counter model SH-6-NU as manufactured by Delfield. Units to be 30" wide x 96" long x 30" high.
- B. Exterior body shall be constructed of 18-gauge stainless steel side panels and 14-gauge galvanized bottom. Provide laminate exterior panels in lieu of stainless steel exterior panels.
- C. Exterior top shall be constructed of 14 gauge, type 304 stainless steel with a No. 3 finish, welded, ground and polished into one integral unit. Top shall have six (6) electrically heated, recessed, die-stamped stainless steel hot food wells.
- D. Hot food wells shall be fully insulated on all sides and bottom and covered with an internal galvanized steel jacket.
- E. Each hot food well shall be individually equipped with a heating element rated at 1000 watts and wired to an adjustable control switch and indicator light in the control panel. Hot food wells shall be inter-wired to a maximum 10' long cord with a grounded plug for 120/208-230 volt, 60 cycle, single phase electrical service.
- F. Unit shall be mounted on 6" high swivel casters with non-marking polyolefin tires and plate brakes.

- A. Furnish one (1) each mobile all-purpose counter model SC-28-NU as manufactured by Delfield. Unit to be 30" wide x 28" long x 30" high.
- B. Exterior body shall be constructed of 18-gauge stainless steel side panels and 14-gauge galvanized bottom. Provide laminate exterior panels in lieu of stainless steel exterior panels.
- C. Exterior top shall be constructed of 14 gauge, type 304 stainless steel with a No. 3 finish, welded, ground and polished into one integral unit.
- D. Unit shall be mounted on 6" high swivel casters with non-marking polyolefin tires and plate brakes.
- E. Unit to be provided with the following accessories:

**ITEM NO. 4**  
**COLD FOOD COUNTER**  
**ONE (1) EACH**

A. Furnish one (1) each mobile cold food counter model SCSC-96-EF as manufactured by Delfield. Unit to be 30" wide x 96" long x 30" high.

B. Exterior body shall be constructed of 18-gauge stainless steel side panels and 14-gauge galvanized bottom. Provide laminate exterior panels in lieu of stainless steel exterior panels. Color of laminate to be determined.

C. Exterior top shall be constructed of 14-gauge, type 304 stainless steel with a #3 finish, welded, ground and polished into one integral unit. The refrigerated cold pan shall be 7" deep and be constructed of 18-gauge stainless steel with ½" diameter coved corners. Top shall have six (6) mechanically cooled die-stamped stainless steel cold food wells.

D. Cold well top to be one-piece stainless steel with 1" overhang around perimeter and die-stamped 11.87" x 19.87" openings with depressed edges. Formed well below each opening is 6.25" deep with .5" drain manifold to gate valve. The cold wells to be manufactured with Eutectic Fluid technology allowing food in food pans to be flush with top of counter and meet NSF standard 7. Temperatures of 33 F to 41 F shall be maintained at 86 F ambient temperature. Sides and bottom are insulated with high-density closed cell polyurethane. Refrigeration system uses HFC-404A refrigerant.

E. Unit shall be refrigerated by a self-contained 115-volt, 60 cycle, single phase hermetically sealed condensing unit with an adjustable cold pan temperature control. Unit shall be wired with a 3-wire, grounded, 10' long cord and NEMA 5-15P plug.

F. Unit shall be mounted on 6" high swivel casters with non-marking polyolefin tires and plate brakes.

G. Unit to be provided with the following accessories:
