Hi Craig,

I've attached some information on our new press-less Panini bread. Please take note of the changes, including the UPC number and case count. The Panini breads will now come as two pre-sliced pieces of bread frozen together, making it a 2 oz equivalent grain serving. This change will also change the case count from 192 to 96 (96 sandwiches instead of 192 individual slices). The start ship for these will be June of 2019. The documents I've attached include the shelf life, nutrition information, and a specific crediting letter for the new UPC.





I have a couple of quick questions on your bid and hope you can help. On the frozen juice section, my Suncup calcium fortified juice cartons are speced under Apple, 4 oz; Fruit Punch, 4 oz.; Grape, 4 oz.; and Orange, 4 oz. The bid spec does not require calcium but some schools used this product many years ago when they needed added calcium as a nutrient. You also have "Mr. J" juice speced and those product codes are their calcium fortified varieties, matching our product codes. However, the Ardmore products listed are NOT calcium fortified. In fact, Ardmore 45431 is not 100% Grape but is a 100% Grape flavored Juice and Ardmore 45430 is a 100% Orange flavored Juice. Both of these products are made from apple juice with added ingredients and flavoring and are not "apple to apples" comparisons to my speced juice.

So my question – Do you want the calcium fortified products, as listed? If so, the four Ardmore brands listed would not meet the spec. If you do not need the calcium fortified products, here are my product codes for the regular 100% juices and spec sheets are attached.

030301 – Suncup 100% Apple Juice 030501 – Suncup 100% Grape Juice 030800 – Suncup 100% Natural Fruit Punch

By the way, no 6 ounce juices are listed. Have you stopped using them?

Second question – May we bid the Suncup shelf stable juice that Michele and I showed you last year. I have attached the full product list. As you know, the distributors will normally default to the brands listed on the bid but we can definitely save your group money on these two lines if you could amend this to include Suncup Juice as an approved brand.


